4 **WHEREAS, at a meeting of the Tohono O'odham Legislative Council, on**  
5 **September 12, 1996, the Tohono O'odham Legislative Council**  
6 **entertained the FY '97 budget for the Hickiwan District; and**

7  
8 **WHEREAS, the Tohono O'odham Legislative Council did discuss at length the**  
9 **Hickiwan District FY '97 Budget; and**

10  
11 **WHEREAS, the sum of \$593,897.54 was appropriated from the gaming revenues**  
12 **to the Hickiwan District, which is in an account in Bank of America;**  
13 **and**

15 **WHEREAS, the Hickiwan District Council does have sufficient funds to cover the**  
16 **FY '97 Budget; and**

18 **WHEREAS, the Hickiwan District Council agrees to set aside funds in the amount**  
19 **of \$224,580.40 to pay for the Salaries and Fringe Benefits line items**  
20 **and \$3,859.35 for Insurance on District vehicles which is in the Bank**  
21 **of America Account in the amount of \$228,439.75.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**  
25 **Legislative Council does approves the FY '97 Budget in the amount**  
26 **of \$593,897.54 for the Hickiwan District.**
