

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Schuk Toak District Budget FY 1997)**

RESOLUTION NO. 96-440

WHEREAS, on August 31, 1996 gaming revenues in the amount of \$593,897.54 was distributed to Schuk Toak District; and

WHEREAS, on Resolution #ST-08-24-96-03 the Schuk Toak District Council did approve the District Budget for FY 1997 in the amount of \$508,087.54; and

WHEREAS, on Resolution #ST-08-24-96-04 the Schuk Toak District Council did also approve that the remaining balance of \$85,810.00 be invested into the District account with Paine Webber, Inc.;; and

WHEREAS, the Schuk Toak District Council requests the Legislative Council to ratify the Schuk Toak District Budget for FY 97.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the FY 1997 budget for the Schuk Toak District in the amount of \$508,087.54 to be expended in accordance with the attached budget and that the remaining balance of the gaming revenue of \$85,810.00 will be invested into the Schuk Toak District's Account with Paine Webber, Inc.


