**WHEREAS, the San Lucy District is currently in the process of reviewing their
financial needs of the District for Fiscal Year 1997; and**

**WHEREAS, the District Council intends to have San Lucy District FY 1997 Budget
and FY 1997 Vi-ikam Doag Industries Budget reviewed for an
approval process completed as soon as possible; and**

**WHEREAS, the San Lucy District Council is asking for approval of continued
operations under FY96 Budget, pending approval of the FY97 Budget
by the District Council and Legislative body; and**

**WHEREAS, it is in the best interest of the San Lucy District that existing
authorizations be continued until such time that the Legislative
Council conducts a thorough review of the budget and approves the
same.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it does
hereby authorizes the San Lucy District and Vi-ikam Doag Industries
to continue their current operations until their FY 97 Budgets are
approved.**

12 of the Act of June 18, 1934 (48 Stat. 984).




