3 **WHEREAS, the Legislative Council did allocate Water Trust Funds for the Water**

5 **Commissioners for the purpose of paying cost for work performed on**

7 **water activities for the Nation; and**

8 **WHEREAS, the Water Commission has been designated as the Water Resource**

10 **Committee and is delegated the responsibility for water activities of**  
11 **the Nation; and**

12 **WHEREAS, the Legislative Council did request that the Water Resources**  
13  
14 **Committee develop a budget and submit to the Legislative Council**  
15  
16 **for consideration and adoption; and**

17 **WHEREAS, the Water Resources Committee has developed and approved a**

19 **budget in the sum of \$116,626.00 effective October 01, 1996 to**  
20  
21 **September 30, 1997.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative**

24 **Council does hereby approve the Water Resources Committee budget**

26 **in the amount of \$116,626.00 effective October 01, 1996 to September**

28 **30, 1997 and that these funds be allocated from the Water Trust**  
**Fund as previously authorized for this committee.**
