**NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Nation does support and endorses the American Diabetes Association.

**BE IT FURTHER RESOLVED** that the Tohono O'odham Nation has provided a contribution of \$15,000.00 that will go towards the 1996 Waltoberfest sponsored by the American Diabetes Association to be held October 6, 1996.

**BE IT FINALLY RESOLVED** that the funds for the 1996 Walktoberfest be allocated from the General Revenue Account.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 20TH day of SEPTEMBER, 1996 at a meeting at which a quorum was present with a vote 1,226.0 FOR; -0- AGAINST; 71.0 NOT VOTING; and 579.0 [08]ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
