

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Sells District FY 97 Budget)**

RESOLUTION NO. 96-467

WHEREAS, the Sells District Treasurer presented the Sells District Budget for FY 97 to the Tohono O'odham Legislative Council for review; and

WHEREAS, all line items in the Sells District FY 97 Budget total \$509,915.16; and

WHEREAS, Sells District Has sufficient funds in their Bond Account to cover this amount for FY 97.

NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves the Sells District FY 97 Budget in the amount of \$509,915.16.

BE IT FURTHER RESOLVED that the remaining amount allocated to Sells District from the Gaming monies will be invested in the Bond Account and will be accessible for use by the District when the need arises with prior approval of the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 26TH. day of SEPTEMBER, 1996 at a meeting at which a quorum was present with a vote 1,759.0 FOR; -0- AGAINST; -0- NOT VOTING; and 117.0 [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
