RESOLUTION NO. 96-468

WHEREAS, the Tohono O'odham Legislative Council has reviewed Resolution No. SD-41-96 entertained by the Sells District Council; and

WHEREAS, the Scholarship Fund does effect a great number of Tohono O'odham students.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council again directs the Chief Financial Officer to release the Scholarship Funds for use by the students who are still in school and the new applicants.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 26TH day of SEPTEMBER, 1996 at a meeting at which a quorum was present with a vote 1,289.0 FOR; -0- AGAINST; 470.0 NOT VOTING; and 117.0 [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(b),(1), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
