6 **O'odham Legislative Council did pass Resolution No. 96-400,**
7 **(Distribution of Mining Royalties by Population); and**

10 **WHEREAS, upon presentation of Resolution No. 96-400 to the Chairman of the**
11 **Tohono O'odham Nation, he did disapprove thereof and returned**
12 **it to the Council with his objections in accordance with the**
13 **provisions of Article VII, Section 5 of the Constitution of the Tohono**
14 **O'odham Nation; and**

17 **WHEREAS, during the October 7, 1996 Legislative Session, the Chairman of the**
18 **Nation presented justification in vetoing Resolution No. 96-400; and**

20 **WHEREAS, the Legislative Council has reviewed the Chairman's objections and**
21 **after consideration again voted to pass Resolution No. 96-400.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative**
25 **Council does hereby override the Chairman's veto by a vote of two-**
26 **thirds of the votes cast.**




