6 **WHEREAS, during the September 10, 1996 General Session the Tohono**  
7 **O'odham Legislative Council did pass Resolution No. 96-403,**  
8 **(Allowing Districts to be Sub-recipients, to do Construction on CDBG**  
9 **Projects within their Respective Districts); and**

12 **WHEREAS, upon presentation of Resolution No. 96-403 to the Chairman of the**  
13 **Tohono O'odham Nation, he did disapprove thereof and returned**  
14 **it to the Council with his objections in accordance with the**  
15 **provisions of Article VII, Section 5 of the Constitution of the Tohono**  
16 **O'odham Nation; and**

19 **WHEREAS, during the October 7, 1996 Legislative Session, the Chairman of the**  
20 **Nation presented justification in vetoing Resolution No. 96-403; and**

21  
22 **WHEREAS, the Legislative Council has reviewed the Chairman's objections and**  
23 **after consideration again voted to pass Resolution No. 96-403.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative**  
26 **Council does hereby override the Chairman's veto by a vote of two-**  
27 **thirds of the votes cast.**



7 ABSENT, failed to pass because it did not receive a (2/3) [1,251.0] of the votes  
8 casts as required by Section 2 of Article V of the Constitution of the Tohono  
O'odham Nation.
