

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override vetoed Resolution No. 96-404, Deletion of FY 1997 O'odham in
Mexico Program Budget of Executive Branch)**

RESOLUTION NO. 96-477

WHEREAS, the Tohono O'odham Legislative Council did approve Resolution No. 96-404 (Deletion of FY 1997 O'odham in Mexico Program Budget of Executive Branch) during the September 10, 1996 General Session; and

WHEREAS, upon presentation of Resolution No. 96-404 to the Chairman of the Tohono O'odham Nation, he did disapprove thereof and returned it to the Council without his objections; and

WHEREAS, during the October 7, 1996 Legislative Session, the Vice Chairman of the Nation presented the justifications in vetoing Resolution No. 96-404; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the Vice Chairman's objections and after consideration again voted to pass Resolution No. 96-404.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby override the Chairman's veto of Resolution No. 96-404 by a vote of two-thirds of the votes cast.
