BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the duration of the agreement shall commence on October 01, 1996 through September 30, 1997.

The foregoing Resolution was passed by the Tohono O'Odham Council on the <u>8TH.</u> day of <u>OCTOBER</u>, <u>1996</u> at a meeting at which a quorum was present with a vote <u>1,876.0</u> FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[04]</u> ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
