**WHEREAS, the Tohono O'odham Legislative Council Resolution 96-442 did approve for San Lucy District to continue operations under their FY 1996 Budget; and**

**WHEREAS, the District Council has prepared and approved their proposed FY 1997 District Budget in the amount of \$1,361,493.05 to cover anticipated cost and expenses from October 01, 1996 to September 30, 1997; and**

**WHEREAS, the San Lucy District has sufficient funds in the District's Gaming Revenue Account to provide for the proposed governmental operations in the amount of \$169,379.52 and P.L. 99-503 funds to provide additional administrative, support, and program operations**
