WHEREAS, the Advocate Program has presented a contract for John M. Neis which confirms and ratifies the terms and conditions related to future services, a copy of which is attached; and

WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of Attorney Contract with John M. Neis on such terms.
