4 **WHEREAS, Section 4 of Article VII of the Constitution of the Tohono O'odham**

6 **Nation charges the Tohono O'odham Legislative Council with the**  
7 **responsibility of appointing judges of the Tohono O'odham Courts;**

9 **and**

10 **WHEREAS, on December 9, 1994, the Tohono O'odham Legislative Council, by**  
11  
12 **Resolution No. 94-524, appointed Nicholas Lewis as a full-time Judge**  
13 **of the Tohono O'odham Courts for a six-year term, with said term**  
14 **to expire on February 01, 2001; and**

16 **WHEREAS, a Removal Accusation was filed with the Judiciary Committee against**  
17  
18 **Judge Nicholas Lewis in accordance with Article IX, Section 2 of the**  
19 **Uniform Election Ordinance; and**

21 **WHEREAS, the Judiciary Committee did conduct a hearing on the accusation on**  
22 **September 30, 1996 and by Resolution JUD-01-96 did determine that**  
23 **there was reasonable cause to believe that Judge Nicholas Lewis had**  
24 **committed a removable offense as charged in the accusation and**  
25 **thereby filed the accusation with the Secretary of the Legislative**

**WHEREAS, on October 3, 1996 Judge Nicholas Lewis submitted a letter of  
resignation for the position and request that said resignation be  
effective October 3, 1996; and**

**WHEREAS, the Judiciary Committee recommends that the Legislative Council  
accept the resignation of Nicholas Lewis as full-time Judge of the  
Tohono O'odham Courts.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
that it hereby formally recognizes and accepts the resignation of  
Nicholas Lewis as a full-time Judge of the Tohono O'odham Courts,  
effective October 3, 1996.**


**The foregoing Resolution was passed by the Tohono O'Odham Council on the  
10TH. day of OCTOBER, 1996 at a meeting at which a quorum was present with  
a vote 1,742.0 FOR; -0- AGAINST; -0- NOT VOTING; and 134.0 [05] ABSENT,  
pursuant to the powers vested in the Council by Article VI, Section 1(b), of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
of the Act of June 18, 1934 (48 Stat. 984).**


