**WHEREAS, the Gu Achi District Council on August 22, 1996 did adopt and approved the FY 97 proposed budget in the amount of \$568,719.86; and**

**WHEREAS, the FY 97 budget of Gu Achi District will be funded by the Gaming Revenues of the Tohono O'odham Nation; and**

**WHEREAS, the Gu Achi District Council is proposing that the Gaming Revenue monies in the amount of \$593,897.54 be deposited in account #59078 with Paine Webber, Inc.; and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed the Gu Achi District FY 97 Budget and desires to invest with Paine Webber, Inc., hereby approves the same.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the Gu Achi District FY 97 Budget to be expended in accordance with the attached budgets.**




