RESOLUTION NO. 96-530

WHEREAS, a request from Hickiwan District came forth to the Tohono O'odham
Legislative Council regarding their FY "97" Budget Amendment #1;
and

WHEREAS, the Hickiwan District Council did discuss and approve the FY "97"
Budget Amendment #1; and

WHEREAS, their original FY "97" Budget was in the amount of \$593,897.54 and
an amendment was needed in the amount of \$2,803.90; and

WHEREAS, the Hickiwan District does have sufficient funds to cover the FY "97"
Budget Amendment #1 in the amount of \$596,701.44.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
that it hereby approves the Hickiwan District's FY "97" Budget
Amendment #1.

BE IT FURTHER RESOLVED that the amount of \$2,803.90 be appropriated from
the gaming revenues distribution to Hickiwan District.

The foregoing Resolution was passed by the Tohono O'Odham Council on the
7TH day of NOVEMBER, 1996 at a meeting at which a quorum was present with
a vote of 1,771.0 FOR; -0- AGAINST; -0- NOT VOTING; and 105.0 [06] ABSENT,
pursuant to the powers vested in the Council by Article VI, Section 1(d)(3), of the
