**WHEREAS, the Tohono O'odham Legislative Council, by Resolution #96-462,**  
**approved and appropriated \$11,110,797.88 to fund the base**  
**operations of the Tohono O'odham Nation's Executive Branch; and**

**WHEREAS, the Chairman of the Nation advised the Legislative Council that the**  
**Executive Branch will prepare and forward for legislative**  
**consideration and approval, an FY 97 Supplemental Budget Request**  
**package (*FY 97 Supplemental Budget*, attached and incorporated into**  
**this resolution by this reference); and**

**WHEREAS, the FY 97 Supplemental Budget requests additional operating, capital**  
**and facility maintenance funding for the various departments and**  
**programs of the Executive Branch, as summarized below:**

**NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative  
Council that it does hereby approve the Tohono O'odham Nation  
Executive Branch's FY 97 Supplemental Budget Request, and  
appropriates \$2,023,935.87 to be expended in accordance with the  
attached budget.
