

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Opposing the STAR PROJECT)**

RESOLUTION NO. 96-533

WHEREAS, the Tohono O'odham Legislative Council has considered the proposal known as the STAR PROJECT which proposes to expand Indian Gaming in Arizona; and

WHEREAS, the STAR PROJECT proposes to expand Class III Gaming; to provide revenue sharing of no more than 10% to the State of Arizona; and to authorize a Statewide Gaming Commission which would have enforcement right on State and Tribal lands; and

WHEREAS, the Legislative Council does not support any portion of this proposal.

NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Nation is authorized and directed to communicate the Nation's opposition to the STAR PROJECT.

BE IT FINALLY RESOLVED that the Tohono O'odham Nation be omitted from the proposed STAR PROJECT.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 7TH. day of NOVEMBER, 1996 at a meeting at which a quorum was present with a vote of 1,424.0 FOR; 142.0 AGAINST; 205.0 NOT VOTING; and 105.0 [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(I), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


