**WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval by the Food Distribution Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve the amendment and authorize expenditures in accordance with the attached Budget Modification No. 1 submitted by the Food Distribution Program.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any**


