

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 1997 Family Preservation Program - Budget Modification #1)**

**RESOLUTION NO. 96-538**

**WHEREAS, the Tohono O'odham Nation is presently operating the Family Preservation Program under FY 1997, P.L. 93-638 grant with the Bureau of Indian Affairs; and**

**WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'odham Legislative Council; and**

**WHEREAS, there has been an increase of \$8,372.00 for FY 1997 Direct Program Funds; and**

**WHEREAS, an amendment has been submitted for review and approval by the Tohono O'odham Department of Human Services - Division of Child Welfare Services/Family Preservation Program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council does approve the amendment to the Family Preservation Program grant and authorizes expenditures in accordance with the attached budget.**

Tohono O'odham Nation's Officials to wit: the Chairman, Vice Chairman and any designated Official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 8TH day of NOVEMBER, 1996 at a meeting at which a quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


