Childhood Head Start and Day Care Program for its young members;**

Food Services Agreement, provides reimbursement of funds for food  
costs incurred based on the guidelines identified in the agreement;**

**WHEREAS, the Tohono O'odham Nation, Head Start, submits for review and  
approval the Child Adult Care Program Budget for Fiscal Year 1997.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that it does hereby approve and authorizes expenditures in  
accordance with the attached budget amount of \$54,036.35.**

duration of the agreement shall commence on October 01, 1996  
through September 30, 1997.**



Tohono O'odham Nation's Officials to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the agreement, provided however, that any amendments affecting the funding or funding levels of the agreement shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 21ST. day of NOVEMBER, 1996 at a meeting at which a quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f), of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


