WHEREAS, the Child Day Care Services Program has been successfully operated
through the Early Childhood Division and has served many Tohono
O'odham children; and

WHEREAS, the Tohono O'odham Legislative Council is desirous of continuing this
program for the benefit of its young members.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it does hereby approve the proposed Budget FY 1997
Tohono O'odham Day Care Services Parent Fee in the amount of
\$43,649.34.

BE IT FURTHER RESOLVED that the duration of the Budget will be from October
01, 1996 through March 31, 1997.



the contract, provided however, that any amendments affecting the
funding or funding levels of the contract shall be submitted for
further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Council on the
21ST. day of NOVEMBER, 1996 at a meeting at which a quorum was present with
a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT,
pursuant to the powers vested in the Council by Article VI, Section 1(f), of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984).
