The foregoing Resolution was presented to the Tohono O'Odham Council on the 3RD. day of DECEMBER, 1996 at a meeting at which a quorum was present and by a vote of <u>575.0</u> FOR; <u>1,019.5</u> AGAINST; <u>281.5</u> NOT VOTING; and <u>[01]</u> ABSENT, failed to pass because it did not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'odham Nation.
