9 **through La Familia Enterprises, to provide entertainment during the**
10 **59th Annual Rodeo & Fair; and**

11 **WHEREAS, the Tohono O'odham Nation is desirous in obtaining the services of**

13 **Little Joe & La Familia for the entertainment of rodeo fans, visitors**

15 **and members of the Nation.**

16 **NOW, THEREFORE, BE IT RESOLVED THAT the Chairman of the Nation is hereby**

18 **authorized to enter into and execute an agreement with La Familia**
19 **Enterprises for the services of Little Joe & La Familia as negotiated**
20 **by the Rodeo & Fair Committee.**

22 **The foregoing Resolution was passed by the Tohono O'Odham Council on the 6TH.**
23 **day of DECEMBER, 1996 at a meeting at which a quorum was present with a vote**
24 **1,537.5 FOR; -0- AGAINST; 233.5 NOT VOTING; and 105.0 [08] ABSENT, pursuant**
25 **to the powers vested in the Council by Article VI, Section 1 (f) of the Constitution**
26 **of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on**
27 **January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**
28 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18, 1934 (48 Stat. 984).


