The foregoing Resolution was passed by the Tohono O'Odham Council on the <u>6TH</u>. day of <u>DECEMBER</u>, <u>1996</u> at a meeting at which a quorum was present with a vote <u>1,537.5</u> FOR; <u>-0-</u> AGAINST; <u>233.5</u> NOT VOTING; and <u>105.0 [08]</u> ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
