

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Change in the Tohono O'odham Nation Scholarship Fund Stipend Scale)**

RESOLUTION NO. 96-576

WHEREAS, the Tohono O'odham Nation Scholarship Fund has found that the stipend scale that is presently used is inconsistent because the largest increase in the stipend scale is \$169.00 and the smallest increase is \$55.00; and

WHEREAS, many students have found that the current stipend scale does not meet their expense needs; and

WHEREAS, the Tohono O'odham Nation Scholarship Fund hereby establishes a revised stipend scale that reflects consistent increments and is more suited to students' need.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it does support, recognize, and authorize the Tohono O'odham Nation Scholarship Fund to remove the currently used stipend scale and replace it with the new stipend scale.

BE IT FINALLY RESOLVED that the new stipend scale will be effective on January 1, 1997.


