RESOLUTION NO. 96-577

**WHEREAS, the Tohono O'odham Nation Scholarship Fund has brought forth its
FY 1997 budget for the sum of \$6,695,299.20; and**

**WHEREAS, this budget will include a total in the amount of \$6,156,343.00 for the
scholarship to be used to fund students for the 1996 - 1997 academic
year; and**

**WHEREAS, as of December 06, 1996, the Tohono O'odham Nation Scholarship
Fund has funded Four Hundred Fourteen (414) students, and is
anticipating the enrollment to increase to Five Hundred Twenty-Nine
(529) for Spring Semester 1997; and**

**WHEREAS, the FY 1997 budget will include four additional positions, which are:
Data Entry Clerk and three Education Assistance Specialists.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it does support, recognize, authorize and approve the
Tohono O'odham Nation Scholarship Fund request for its FY 1997
budget at \$6,695,299.20.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the
Tohono O'odham Nation's officials to wit: the Chairman and any**

designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 6TH. day of DECEMBER, 1996 at a meeting at which a quorum was present with a vote 1,771.0 FOR; -0- AGAINST; -0- NOT VOTING; and 105.0 [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


