RESOLUTION NO. 97-002

WHEREAS, the Tohono O'odham Legislative Council did approve Resolution No. 96-559 (Authorizing the purchase of Equipment to provide Emergency Response to Tohono O'odam Nation) during the December 5, 1996 General Session; and

WHEREAS, upon presentation of Resolution No. 96-559 to the Chairman of the Tohono O'odham Nation, he did disapprove thereof and returned it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham Nation; and

WHEREAS, during the January 6, 1997 Legislative Session, the Chairman of the Nation presented his justifications in vetoing Resolution No. 96-559; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the Chairman's objections and after consideration again voted to pass Resolution No. 96-559.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby override the Chairman's veto of Resolution No. 96-559 by a vote of two-thirds of the votes cast.
