**WHEREAS, Region IX of the United States Environmental Protection Agency
Regional Tribal Operations Committee (RTOC) has informed the
Tohono O'odham Nation of two vacancies for Tribal Representatives
from Arizona to the RTOC; and**

**WHEREAS, by Resolution No. 97-019 the Tohono O'odham Legislative Council did
nominate Alex J. Ramon to the RTOC; and**

**WHEREAS, Kenneth Williams has also been nominated to the RTOC due to his
present involvement with U.S. EPA's Good Neighbor Environmental
Board.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council hereby amends Resolution No. 97-019 to include the
nomination of Kenneth Williams.**

**BE IT FINALLY RESOLVED that the Legislative Council hereby approves the
nominations of Alex J. Ramon and Kenneth Williams for submission
to the U.S. EPA Region IX RTOC to serve as Arizona Tribal
Representatives on the Regional Tribal Operations Committee (RTOC).**


