RESOLUTION NO. 97-023

WHEREAS, the Tohono O'odham Nation is presently operating the JOBS Title IV-F Program funded by the Department of Health and Human Services, Family Support Administration (DHHS/FSA); and

WHEREAS, Public Law 100-485, the Family Support Act of 1988, was enacted into law on October 13, 1988 to revise the AFDC Program to emphasize work, child support, and family benefits to amend Title IV of the Social Security Act, to encourage and assist needy children and parents under the program to obtain the education, training and employment needed to avoid long term welfare dependence; and

WHEREAS, the JOBS Program has submitted a program modification for Fiscal Year 1997 for review and approval by the Tohono O'odham Legislative Council.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the FY 97 JOBS Title IV-F Program Modification #1 and authorize expenditures in accordance with the attached modification #1.
