4 **WHEREAS, the Tohono O'odham Legislative Council on January 15, 1997 of the**

10 **WHEREAS, Resolution No. 534-85, gives issuance of permit to Anita Clark, a**

15 **District to be in compliance with all tribal sanitation laws; and**

16 **WHEREAS, Resolution No. 534-85 does not authorize an establishment of Anita's**

18 **Propane Service to conduct business on the Nation (Sells Community);**

21 **WHEREAS, Sells District Community has raised concerns regarding the**

23 **seriousness of a gas leak incident which occurred on January 11, 1997**

25 **in the Sells Community, and the filling of propane in defective**
26 **storage tanks, and numerous responses from the Fire Department**

Anita's Propane Service operations in order to insure the health and safety of Tohono O'odham Nation members.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby rescinds Resolution No. 534-85, "Approving issuance of permit to Anita Clark".

BE IT FURTHER RESOLVED by the Legislative Council that it hereby directs Anita's Propane Service to immediately cease operations and remove storage tanks housed at the establishment within five (5) days upon approval of this resolution.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 15TH day of JANUARY, 1997 at a meeting at which a quorum was present with a vote 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (c)(2) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


