

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Expansion of Existing "Dance Floor" at Livestock Complex)**

4 **WHEREAS, the Tohono O'odham Nation's Rodeo & Fair Committee has**  
5 **contracted with "Little Joe y La Familia" to perform on Saturday,**  
6 **February 2, 1997. The location of the concert and dance is at the**  
7 **existing haystack barn of the Livestock Complex. A concrete slab**  
8 **has been used over the years as a dance floor for the annual rodeo**  
9 **"Chicken Scratch" dance; and**

13 **WHEREAS, this year, with the inclusion of "Little Joe y La Familia" as the**  
14 **headline performer, it is anticipated that a large number of rodeo**  
15 **fans, dancers and Little Joe fans will be on hand for the**  
16 **performance; and**

19 **WHEREAS, in the past, the rodeo dance has been popular with many local**  
20 **people, as well as visitors attending the dance. At these dances the**  
21 **existing dance floor has always been crowded and full with dancers;**

25 **WHEREAS, it is the recommendation of the Rodeo & Fair Committee that, if**  
26 **possible, funds in the amount of \$9,000 be provided to allow for the**  
27 **expansion of the existing "dance floor" to accommodate the**

3 anticipated large crowd and would also accommodate larger storage  
4  
5 of hay when needed; and

6 **WHEREAS,** the Budget & Finance Committee did review and recommend  
7  
8 approval of the expansion costs.

9 **NOW, THEREFORE, BE IT RESOLVED** that Tohono O'odham Legislative Council  
10  
11 hereby supports the expansion of the existing dance floor and  
12  
13 appropriates \$9,000 for the expansion costs from the General  
14  
15 Revenue Account.

16 The foregoing Resolution was passed by the Tohono O'Odham Council on the  
17 15TH day of JANUARY, 1997 at a meeting at which a quorum was present with  
18 a vote 1,689.0 FOR; -0- AGAINST; -0- NOT VOTING; and 187.0 [07] ABSENT,  
19 pursuant to the powers vested in the Council by Article VI, Section 1 (d)(2) of the  
20 Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
21 Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
23 of the Act of June 18, 1934 (48 Stat. 984).


