**RESOLUTION NO. 97-049**

**WHEREAS, the Tohono O'odham Nation is currently operating the Tohono O'odham Department of Human Services, Division of Senior Services Program with Nation's funds; and**

**WHEREAS, the Legislative Council has approved funding for Case Management positions (in Social Service and ALTCS) and for positions to provide home maker services to elders; and**

**WHEREAS, these positions in Senior Services are now filled, but the Division is in need of vehicles for the staff to make home visits to clients throughout the Nation and to clients in Nursing Homes; and**

**WHEREAS, the Division requests \$62,000 to purchase 4 vehicles for staff to utilize in order to provide needed services.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the Division for Senior Service funding request for vehicles in order to address the needs of Elderly in the amount of \$62,000 and authorizes expenditures in accordance with the attached budget.**

**BE IT FINALLY RESOLVED that the source of funding will be the General Revenue Account.**
