**WHEREAS, the Tohono O'odham Nation established the Tohono  
O'odham Fire Department in 1995 to provide fire protection  
and fire safety to all members of the Nation; and**

**WHEREAS, the Tohono O'odham Legislative Council recognizes the need  
to establish a Nation wide Fire Department to meet the  
needs that exist in all areas of the Nation; and**

**WHEREAS, the Commerce and Budget & Finance Committees of the  
Legislative Council recommends the approval of the  
Supplemental Budget request for the Tohono O'odham  
Nation Fire Department.**

**NOW , THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council hereby approves the supplemental FY 97 budget  
request in the amount of \$158,294.00 for the Tohono  
O'odham Nation Fire Department**

**BE IT FINALLY RESOLVED that the source of funding for the request be  
appropriated from the General Revenue Account.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 7TH. day of FEBRUARY, 1997 at a meeting at which a  
quorum was present with a vote of 1,143.5 FOR; 430.0 AGAINST; 302.5 NOT  
VOTING; and [06] ABSENT, pursuant to the powers vested in the Council  
by Article VI, Section 1(d)(2) & (3) the Constitution of the Tohono O'Odham  
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and**


