**WHEREAS, the Tohono O'odham Legislative Council did approve
Resolution No. 97-058 (Approving the FY 97 Supplemental
Funding Request for the Tohono O'odham Fire Department
in the amount of \$158,294.00); during the February 07, 1997
General Session; and**

**WHEREAS, upon presentation of Resolution no. 97-058 to the Chairman
of the Tohono O'odham Nation, he did disapprove thereof
and returned it to the Council with his objections in
accordance with the provisions of Article VII, Section 5 of the
Constitution of the Tohono O'odham Nation; and**

**WHEREAS, during the February 25, 1997 Special Session, the Chairman
of the Nation presented his justifications in vetoing
Resolution No. 97-058; and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed the
Chairman's objections and after consideration again voted
to pass Resolution No. 97-058.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council does hereby override the Chairman's veto of
Resolution No. 97-058 by a vote of two-thirds of the votes cast.**


