5 **WHEREAS, pursuant to the Native American Housing Assistance and**
6 **Self-Determination Act (NAHASDA) a negotiated rulemaking**
7 **process is being conducted to produce implementing**
8 **regulations for the NAHASDA; and**

9 **WHEREAS, the new Housing Act would allow the Tohono O'odham**
10 **Nation to assume greater responsibility and control over**
11 **Indian Housing and Federally assisted housing programs;**
12 **and**

13 **WHEREAS, it is in the best interest of the Nation to participate in this**
14 **negotiated rulemaking process.**

15 **NOW, THEREFORE, BE IT RESOLVED that Councilwoman Lucille Encinas**
16 **shall serve as the Nation's representative and Chairman**
17 **Edward Manuel shall serve as her alternate.**

18 **The foregoing Resolution was passed by the Tohono O'Odham Legislative**
19 **Council on the 25TH. day of FEBRUARY, 1997 at a meeting at which a**
20 **quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT**
21 **VOTING; and [04] ABSENT, pursuant to the powers vested in the Council**
22 **by Article VI, Section 1(b) & (j) of the Constitution of the Tohono O'Odham**
23 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and**
24 **approved by the Acting Deputy Assistant Secretary - Indian Affairs**
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984).
