

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriation Proposal for Grant Agreement 6-FG-32-00100)**

RESOLUTION NO. 97-068

WHEREAS, the Secretary of Interior bears the responsibility for the completion of designs and construction of facilities for the Schuk Toak New Farm project under the Southern Arizona Water Rights Settlement Act of 1982 (SAWRSA); and

WHEREAS, the Tohono O'odham Nation did enter into a four-year P.L. 93-638 Grant Agreement (6-FG-32-00100) to complete construction of the farm projects during 1996-1999; and

WHEREAS, the Nation's Water Projects Office has developed four-year projections for direct and indirect costs associated with construction and administration efforts under the P.L. 93-638 Grant Agreement totaling approximately \$23.3 million.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the Secretary of Interior be made aware of the estimated cost projections so that future funding may be timely and properly appropriated and allocated by the Federal Government.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 25TH. day of FEBRUARY, 1997 at a meeting at which a quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(j) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
