14 **Council's determination in accordance with Section 4 of**
15 **Article III of the Enrollment Ordinance; and place the names**
16 **of each applicant upon the membership roll of the Tohono**
17 **O'odham Nation in accordance with Article V of the**
18 **Enrollment Ordinance.**

28 **1986; and approved by the Acting Deputy Assistant Secretary - Indian**
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).
