**RESOLUTION NO. 97-081**

**WHEREAS, the Tohono O'odham Legislative Council did approve through Resolution No. 96-109 the expenditure of funds to initially retain Mr. Natman Schaye to represent Mr. George Ignacio before the 9<sup>th</sup> Circuit Court of Appeals; and**

**WHEREAS, Mr. Schaye did prepare and file appeal on Mr. Ignacio's behalf; and**

**WHEREAS, as a result of the brief filed by Mr. Schaye, the 9<sup>th</sup> Circuit Court of Appeals has ordered oral argument be heard on Mr. Ignacio's claim on March 14, 1997 in San Francisco; and**

**WHEREAS, Mr. Ignacio has made a request in the amount of \$5,125.00 to pay for the required legal work, including preparation and presentation of oral argument on March 14; and**

**WHEREAS, the Tohono O'odham Legislative Council did review Mr. Ignacio's request and found it to be appropriate to retain Mr. Schaye; and**

**WHEREAS, the source of funds for this contract shall be an appropriation from the Nation's general funds in the amount of \$5,125.00.**

**NOW, THEREFORE, BE IT RESOLVED that:**

The Chairman of the Nation is authorized to enter into the attached Attorney Contract with Natman Schaye, in the amount of \$5,125.00, from the General Fund for the purpose of providing representation for Mr. George Ignacio in oral argument in Case 96-15509 (Ignacio v U.S.A.) on March 14, 1997 before the U.S. Court of Appeals for the Ninth Circuit.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 3RD. day of MARCH, 1997 at a meeting at which a quorum was present with a vote of 1,693.0 FOR; -0- AGAINST; -0- NOT VOTING; and 183.0 [07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and Section 2(a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
