

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Nation Administrative Plan)**

RESOLUTION NO. 97-082

WHEREAS, the Constitution of the Tohono O'odham Nation, Article VII, Section 2(a) mandated the Chairman of the Tohono O'odham Nation to develop an Administrative Plan to be approved by the Tohono O'odham Legislative Council; and

WHEREAS, the Chairman of the Tohono O'odham Nation has submitted an Administrative Plan to provide administration and management of the government, providing guidance and direction for the employees under the Executive Branch in the delivery of services, outlining the governmental structure of the Executive Branch; and

WHEREAS, the Administrative Plan identifies the issues facing the Tohono O'odham Nation today and in the 21st Century, setting short and long-term goals to meet the priorities of Housing, Economic Development and Job Creation, Health and Welfare of the People, Education and Training, Transportation, and Planning; and

WHEREAS, the Administrative Plan was presented to the eleven districts of the Nation, the Legislative Council, and the people for input.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves the Administrative Plan.
