WHEREAS, the Tohono O'odham Department of Human Services has the primary responsibility to provide prevention and intervention services to families at risk for child abuse and neglect; and

WHEREAS, the Arizona Department of Economic Security provides funds for the development and administration of child abuse and neglect prevention programs under specified terms and conditions; and

WHEREAS, Parent Training has been identified as one means of preventing child abuse and neglect; and

WHEREAS, the Tohono O'odham Department of Human Services has submitted a FY 1998 proposal for Parenting Skills for review and approval.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative

Council that:

- 1. That it hereby approves the application of the Tohono O'odham Department of Human Services for a contract to focus on decreasing the incidence of child abuse and neglect through the provision of parent effectiveness**

2. That the term of this contract shall commence on July 01, 1997 and end of June 30, 1998.

3. That the Tohono O'odham Nation's officials to wit: the Chairman and Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendment affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 7TH. day of MARCH, 1997 at a meeting at which a quorum was present with a vote of 1,716.0 FOR; -0- AGAINST; -0- NOT VOTING; and 160.0 [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
