**RESOLUTION NO. 97-097**

**WHEREAS, the Tribal Employment Rights Office has been administering  
the departmental budget funds for fiscal year 1997; and**

**WHEREAS, the Tribal Employment Rights Office is now requesting the  
Tohono O'odham Legislative Council to approve Budget  
Modification No. 01 which increases the program funds from  
\$205,152.95 to \$212,291.76 for the duration of fiscal year  
1997; and**

**WHEREAS, the amount of \$7,138.81 are revenues received from the  
National Forest Service.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council hereby approves the Tribal Employment Rights  
Office FY'97 Budget in the amount of \$212,291.76.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 7TH. day of MARCH, 1997 at a meeting at which a quorum  
was present with a vote of 1,379.0 FOR; -0- AGAINST; -0- NOT VOTING; and  
497.0 [07] ABSENT, pursuant to the powers vested in the Council by Article  
VI, Section 1(d)(3) of the Constitution of the Tohono O'Odham Nation,  
adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat. 984).**
