

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1997 Child Adult Care Food Program Budget)**

RESOLUTION NO. 97-098

WHEREAS, the Tohono O'odham Nation has operated successfully an Early Childhood Head Start and Day Care Program for its young members; and

WHEREAS, Arizona State Department of Education, through a Child Adult Care Food Services Financial Agreement, provides reimbursement of funds for food cost incurred based on the guidelines identified in the agreement; and

WHEREAS, the Early Childhood, Head Start, Day Care Program submits for review and approval of the Child Adult Care Food Program Budget Modification #1 for Fiscal year 1996 - 1997.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve and authorize expenditures in accordance with the attached budget amount \$54,036.35.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the duration of the agreement shall commence on October 01, 1996 through September 30, 1997.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the

3 affecting the funding or funding levels of the agreement
4 shall be submitted for further prior approval by this Council.

11 adopted by the Tohono O'Odham Nation on January 18, 1986; and

13 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
14 18, 1934 (48 Stat. 984).
