

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Election Board Budget Supplement for Special Election)**

RESOLUTION NO. 97-116

WHEREAS, the Tohono O'odham Election Board has been administering budget funds for fiscal year 1997; and

WHEREAS, the Tohono O'odham Election Board is now requesting the Tohono O'odham Legislative Council to approve the supplemental budget which increases the program funds by \$17,870.40 for Fiscal Year 1997; and

WHEREAS, the amount of \$17,870.40 are from the General Funds.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves the Tohono O'odham Election Board Supplemental in the amount of \$17,870.40, with funds to be appropriated from the General Revenue Account.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH. day of APRIL, 1997 at a meeting at which a quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3) the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
