7 **O'odham Nation, the San Xavier and Schuk Toak Districts,**
8 **and the San Xavier allottees regarding water rights under**
9 **the Southern Arizona Water Rights Settlement Act of 1982;**

26 **& (i)(1) of Article VI and Article XVII of the Constitution of the Tohono**
27 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,**
28 **1986; and approved by the Acting Deputy Assistant Secretary - Indian**
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).




