

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to the Attorney Contract with
California Indian Legal Services)**

RESOLUTION NO. 97-119

WHEREAS, by Resolution 96-519, the Tohono O'odham Legislative Council approved an Attorney Contract with California Indian Legal Services to provide legal representation to the Nation in connection with certain cases pending in California under the Indian Child Welfare Act; and

WHEREAS, the Attorney Contract is in the amount of \$10,000 for fiscal year 1997; and

WHEREAS, the additional sum of \$9,000 is required for legal fees and expenses to assure uninterrupted legal representation for fiscal year 1997; and

WHEREAS, sufficient funds are available in the budget of the Office of Attorney General to supplement the Attorney contract by such amount; and

WHEREAS, the Domestic Affairs Committee recommends approval of Amendment No. 1 to the Attorney General Contract to increase the Contract amount by \$9,000.

NOW, THEREFORE, BE IT RESOLVED THAT:
