

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Transferring Building 416 in Santa Rosa to Gu Achi District)**

**RESOLUTION NO. 97-120**

**WHEREAS, by Resolution Nos. 143-82 and 08-83, the Nation accepted transfer of buildings from the Bureau of Indian Affairs; and**

**WHEREAS, by District Council Resolution No. 0494-85B, the Gu Achi District Council requested that the Nation transfer the buildings obtained from the BIA to the Gu Achi, and also requested that the Nation conduct an environmental assessment survey on the buildings; and**

**WHEREAS, by Resolution No. 94-479, the Nation supported the request made by the Gu Achi District Council to transfer the buildings when the facilities are inspected and declared safe; and**

**WHEREAS, building 416 has now been inspected by the Nation's Operations and Planning Department and declared environmentally safe for its intended use as a laundromat.**

**NOW, THEREFORE, BE IT RESOLVED THAT building 416 located in Santa Rosa, Gu Achi District, is hereby transferred to the Gu Achi District Council.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 11TH. day of APRIL, 1997 at a meeting at which a quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1(i) and Section 2(d) of Article VI of the Constitution of the Tohono O'Odham**
