**RESOLUTION NO. 97-123**

**WHEREAS, the Tohono O'Odham Nation has entered into an Intergovernmental Agreement with the State of Arizona to provide ALTCS Case Management services to eligible enrolled members; and**

**WHEREAS, the Tohono O'Odham Nation has been providing ALTCS Case Management services since June 1996 and has been receiving reimbursement from the State of Arizona for these services; and**

**WHEREAS, the funds received are needed to continue the operation of the ALTCS program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council,**

- 1. that it hereby approves and authorizes expenditures in accordance with the attached budget in the amount of \$66,669.00.**
- 2. that it hereby approves the budget period, April 01, 1997 through September 30, 1997 (a period of six months).**
- 3. that it hereby approves that ALTCS revenues will be accumulated in a separate account, including the remaining \$14,744.52, and that account be invested and**

9 the grant, provided however, that any amendment  
10 affecting the funding or funding levels of this contract

23 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
