**RESOLUTION NO. 97-124**

**WHEREAS, the Tohono O'Odham Department of Human Services under the Executive Office and the Legislative Branch of the Tohono O'Odham Nation has had a long term interest in providing Long Term Care to its members; and**

**WHEREAS, the Tohono O'Odham Nation has been providing ALTCS Case Management services since June 1996 and has been receiving reimbursement from the State of Arizona for these services; and**

**WHEREAS, the ALTCS budget - Account #01 -1 416 was approved for a six (6) month period (October 01, 1996 through March 31, 1997; in the amount of \$86,708.00 and**

**WHEREAS, there are funds in the amount of \$11,446 not spent in line items that are needed for continuing operations of the ALTCS program**

**WHEREAS, the ALTCS program is requesting that the remaining funds be reobligated according the attached budget.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council,**

**1. that it hereby reobligates the remaining ALTCS budget**

**3. that the Tohono O'Odham Nation's officials to wit: the Chairman and Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, provide however, that any amendment affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 11TH day of APRIL, 1997 at a meeting at which a quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; 0 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d),(2) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
