**WHEREAS, the Tohono O'odham Nation is presently operating the
Community Health Services Program under FY 1997 P.L. 93-
638 Master Health Contract No. 249-96-0001 with the Indian
Health Services; and**

**WHEREAS, the Tohono O'odham Nations' Grants and Contracts Office
has notified the Community Health Representative/
Community Health Services Division of FY96 savings in the
amount of \$60,000 is available for obligation under the FY97
Master Health Contract; and**

**WHEREAS, any amendments affecting the funding or funding levels of
the contract shall be submitted for review and approval by
the Tohono O'odham Legislative Council; and**

**WHEREAS, a budget is submitted for review and approval by the
Department of Human Services, Divisions of Community
Health Representatives/Community Health Services.**

NOW, THEREFORE, BE IT RESOLVED:
